ARCHITECTURAL CONTROL COMMITTEE – IMPROVEMENT REQUEST FORM

In accordance with the recorded covenants, conditions and restrictions of the association, and in order to protect each individual owner's rights and values, it is required that any owner who is considering improvement of his deeded property to include, but not be limited to patio covers, decks, outside buildings, fencing, building add-ons, etc., submit the following to the Architectural Control Committee **prior to initiating work on the planned improvement**:

- 1) Completed *Improvement Request Form*
- 2) Include complete and detailed building plans, material listing and specifications
- 3) Provide a property/site survey plan showing the location of the proposed improvement (Note: Please provide specific measurements, preferably to scale, as it relates to your home and lot.)

FAILURE TO SUBMIT THE REQUESTED ATTACHMENTS (ITEMS 1, 2 & 3) PRIOR TO CONSTRUCTION MAY RESULT IN DENIAL OF YOUR REQUEST FOR IMPROVEMENT. Any improvement made without ACC approval, is subject to enforcement action by the Covenant's Committee or the SRHOA Board. Any homeowner considering any exterior improvement to his properties is urged to review the recorded deed restrictions prior to initial request.
